BACKGROUND:

State law (A.R.S 41-1279.07(C)) requires that an Annual Financial Report be completed and submitted within 9 months of the end of each fiscal year (June 30). The Annual Financial Report is considered the official record of the City's financial activity for that period of time. There are four parts to a Comprehensive Annual Financial Report (CAFR): the Transmittal Letter, the Management Discussion and Analysis (MD&A), the Financial Statements and Notes, and the Statistical Section. The FY2019 CAFR will be submitted for the Government Finance Officers Association Certificate of Achievement for Excellence in Financial Reporting.
